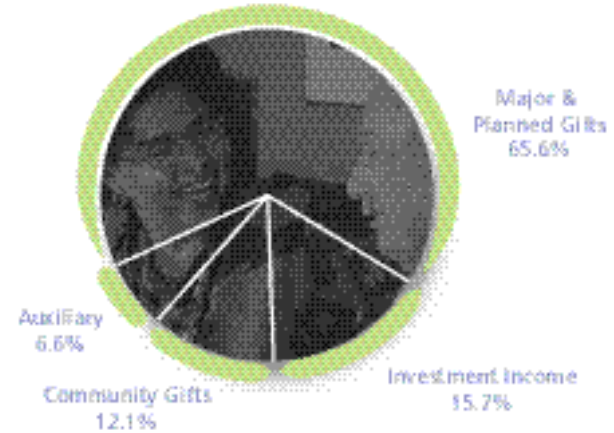

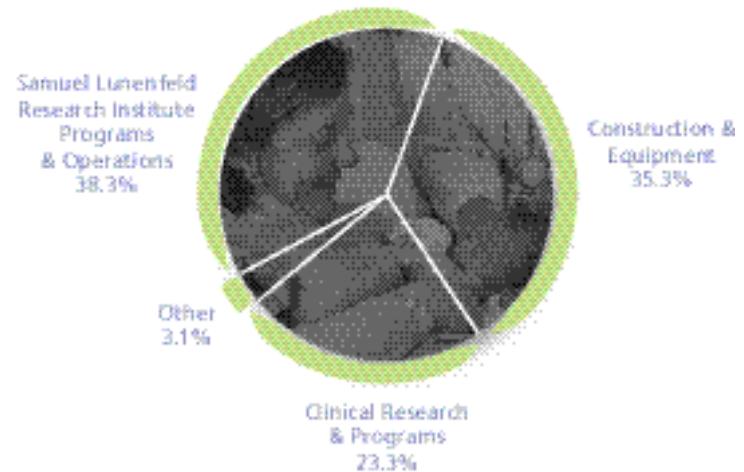
### Revenue from all sources 2001/2002

The goal of the **Sam & Judy Pencer and Family Chair in Applied General Psychiatry** is to make practical systemic changes in mental health care delivery in order to reach communities who are missed by the current model, says Chair holder Dr. Joel Sadavoy. The Chair was funded a year ago and the first project is a Wellness Centre in the Chinese community. Located in a storefront within one of Toronto's Chinese neighborhoods, it is meant, above all, to be accessible. It brings together tenets of Chinese and Western medicine and is run in concert with partners in the Chinese community. Other projects include research into early identification of individuals at risk of mental disorders and the importance of family and community ties in maintaining mental health. We note with sadness the recent passing of Sam Pencer.

Since its installation in the Spring of 2001, the **Kimel Family MRI (Magnetic Resonance Imaging) Centre** has had a great positive impact on patient care at Mount Sinai. Our patients, who previously waited up to nine months to be tested at an off-site MRI, now have access to highly detailed test results much sooner. This means improved patient comfort and less stress for anxious patients and their families. Each week, 175 patients now have MRI tests at Mount Sinai. In the first 16 months of operation, over 7,000 patients were tested. With 24-hour on-site emergency access to MRI service, patients arriving in the Schwartz/Reisman Emergency Centre can now receive MRI tests without having to be referred to another hospital.

Every year, more than 100 orthopaedic transplants are performed at Mount Sinai on patients from all over the world. Dr. Gross is the holder of the **Bernard I. Ghert Family Foundation Chair in Orthopaedics**, established in 2000 to support his research program. Proceeds from the Chair are currently directed towards the research of Dr. David Backstein, a specialist in reconstructive lower extremity surgery. Dr. Backstein is investigating educational methodologies for surgeons to identify those that create optimal learning and translate into best practices in patient care.

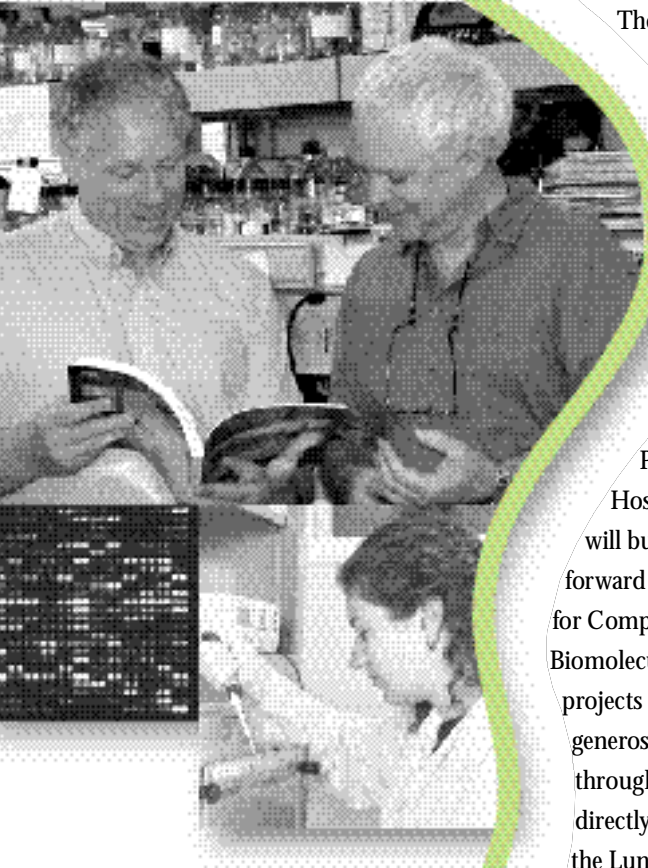

Dr. Tony Pawson was appointed Director of Research at the Institute while Dr. Stephen Lye took on the positions of Associate Director of Research at the Institute and Vice-President – Research at Mount Sinai Hospital. Under their direction, the Lunenfeld will build on its record of achievement and move forward with new initiatives like the Toronto Centre for Comparative Models of Human Disease and the Biomolecular Interaction Network Database. These projects and many others are possible thanks to the generosity of donors. Not only do dollars raised through *The Best Medicine* campaign contribute directly to the medical research breakthroughs at the Lunenfeld, they help us to leverage additional funds through grants, awards and public and private sector partnerships. - ◆ Scientists within the Institute are world leaders in their research fields. The **Scientific Leadership Fund** contributes to providing competitive, stable remuneration to help ensure their retention.
- ◆ Some of the world's best graduate, doctoral and post-doctoral trainees are attracted to the Lunenfeld by the opportunity to work with our outstanding faculty and research facilities. The **Young Scientist Fund** provides stipends for these trainees.
- ◆ New technologies and techniques are fundamental to today's revolution in biomedical research. The **Frontiers of Science Fund** allows us to obtain state-of-the-art tools needed to make critical advances in health research.
